Call meeting to order: Ken Comer, Chair, called the meeting to order at 7:08 pm.

Review/approval of February 2023 minutes: Ms. Iannetta noted the review and approval of the February minutes would be deferred.

Presentation - Coalition for Smarter Growth: Sonya Breehey began her presentation with an overview of their mission. The group covers the Metro DC area and Sonia covers the Northern VA area. They advocate for walkable, bikeable, inclusive, and transit-oriented communities as the most sustainable and equitable way for the Washington, DC region to grow and provide opportunities for all. She showed pictures of large vacant parking lots and massive highway widenings which they consider detrimental to the community. The Coalition published a "Blueprint for a Better Region" for putting development in the right place. She demonstrated how

the Arlington, VA region developed around the WMATA Metro. She included data showing the difference between walk-bike mode vs auto dependent mode as well as before and after transformation of urban development. She noted dangerous arterials in Fairfax and how their group is keeping pressure where necessary for areas like the Route 7 and Route 1 corridors. She described the local efforts working to influence the proposed Route 1 cross sections. She noted the Safe Streets for Bailey's Crossroads ongoing initiative between the Coalition and CASA with a walkability survey and Audit Report to help evaluate community and to have their concerns heard. Ms. Breehey co-coordinates with the Fairfax Heathy Communities which brings a number of groups into a network; FHC Trails Workgroup attempts to brings environmental and trail advocates together to build trust and work together. She shared her contact information. She noted an upcoming event at MetroBar in NE DC. Mr. Comer noted this committee recently sent a pedestrian safety letter to the Board of Supervisors including recommendations for a turn calming program and that existing crosswalks with fatalities do not get eliminated. He noted that typically user groups are split between recreational cyclists and commuter cyclists and the trail type/design caters to one than the other. Ms. Breehey responded that her group tries to answer to both groups and thinks the facilities can be more than "this or that". Mr. Albright noted Route 7 Culmore conversations with VDOT and how projects are planned 10 years in advance. This creates a disconnect on spot improvements which have a more immediate need. Ms. Breehey has witnessed VDOT's reluctance to stripe and install flex posts on roadways to designate a space using VDOT policy and bureaucracy with rotating excuses. Mr. Albers inquired how the Coalition could get help from this committee. The Columbia Pike study is completed but lacks funding. Mr. Stephens commented on street design and integrating cycling into the cross section where VDOT standard answer is "no". Ms. Breehey stated she has found some avenues for hope in their advocacy but noted it has mainly been incremental change. She considered the improvements around the Vienna metro a positive collaborative effort. Mr. Newman commented that the Coalition has a large email network to create campaigns to help spread the word. Mr. Comer suggested it might be useful to create a counternarrative to those who support trees and advocate against removal. However, the tree canopy gets replaced/replanted as part of the projects.
