#### **FY 2017 Budget Public Hearings**

The Board of Supervisors will hold three days of public hearings on the Advertised Fiscal Year 2017 Budget. They will be April 5<sup>th</sup> at 4:00 p.m., April 6<sup>th</sup> and April 7<sup>th</sup> at 1:00 p.m. I encourage you to send me your thoughts on the budget by emailing me at <a href="mailto:mtvernon@fairfaxcounty.gov">mtvernon@fairfaxcounty.gov</a> or testifying before the Board by contacting the Clerk to the Board of Supervisors at 703-324-3151. The Board of Supervisors set an advertised tax rate at \$1.13 per \$100 of assessed value, a 4 cent increase. The Board of Supervisors can adopt a lower rate than this, but not a higher one. The General Assembly has adjourned and their approved biannual budget has the Commonwealth increasing their contribution to Fairfax County Public Schools by \$21 million, which is almost 1 cent on the Fairfax County Real Estate Tax Rate. Even with this increase, the School Board reports there are still unmet needs like keeping teacher compensation competitive, reducing class sizes and capping maximum elementary school classes below 30 students. This underscores the need for Fairfax County Government to diversify its tax base. The Real Estate Tax rate makes up about 65% of our revenues. The real estate tax is regressive and is not an accurate reflection of a taxpayer's ability to pay the tax. The County Executive has informed the Board during our Lines of Business Review meetings that Fairfax County has the authority to levy other taxes like an entertainment tax on ticket sales, which could bring in \$6 million a year; a probate tax on wills, which could generate \$300,000 a year; and a meals tax, which could bring in \$90 million a year.

#### **Update on General Assembly Activities**

The 2016 General Assembly adjourned on Friday, March 11. This session had both its roses and its thorns for Fairfax County. The General Assembly passed a new 2016-2018 biennium budget, which contains good news for Fairfax County and Fairfax County Public Schools (FCPS). The budget partially restores \$5.6 million in Cost of Competing Adjustment (COCA) for K-12 support staff in FY 2017 and \$5.8 million in FY 2018. COCA is an additional factor in the state K-12 funding formula that recognizes the higher salaries required in high-cost areas of the Commonwealth to attract and retain highly qualified staff.

For Fairfax County, we are projecting nearly \$21 million – almost a penny on the tax rate – in anticipated additional state funding for Fairfax County Public Schools in FY 2017. Unfortunately, the General Assembly did consider a number of bills that diminish the County's land use authority. The most consequential of these bills, related to proffers, has already been signed into law by Governor McAuliffe. That legislation includes numerous exemptions from the new requirements that will be especially helpful for Fairfax County, however it does negatively impact our ability to obtain proffers for new development, which is funding set aside to lessen the impact of development of schools, roads, parks and other infrastructure. This law will require taxpayers to shoulder more of the burden of development costs and strips some authority of local government to deny land use cases. It is a law that needs to be amended or repealed in future sessions.

In addition, legislation governing short-term rentals in residential areas (such as Airbnb) would have diminished local land use authority as introduced, but after significant negotiation and effort, the legislation includes a study of the issue and a requirement that any related legislation be enacted by the 2017 GA.

Next, HB883, a bill that removes the requirement for a public hearing before a local planning commission where telecommunications towers are permitted by right, which is on industrially zoned land in Fairfax

County. The County obtained an exemption in the bill for Planning District 8 (which is Northern Virginia), to allow us to maintain our process for public input on these towers. That process has worked well for the County and the community. Unfortunately, the exemption for Planning District 8 was removed from the bill on the Senate floor at the very end of the session by a member of our delegation — as a result, no public hearing is now required for telecommunications facilities on industrially zoned land. #### **North Hill Comprehensive Plan Amendment Update**

On Tuesday, March 1<sup>st</sup>, I introduced a motion to amend the Comprehensive Plan to permit new development at the North Hill site. This is an exciting development opportunity that allows us to provide a mix of affordable, workforce and market rate housing while accomplishing the goals of EMBARK Richmond Highway and provide acreage for a public park.

The Comprehensive Plan amendment, which is the first step in the redevelopment of the site followed by a rezoning application, would permit the construction of 278 multi-family rental units in six separate, high quality, urban designed buildings with structured parking; dedicate 10 percent of the units for households with an annual income at or below 30 percent of the Area Median Income (AMI), 20 percent of the units for households with an annual income at or below 50 percent of the AMI, and have the remaining units for households with an annual income at or below 60 percent of the AMI. (Washington AMI for a family of four is \$109,200.) There will be a **community meeting** about the development at **Walt Whitman Middle School's Lecture Hall on April 27<sup>th</sup> from 7:00 p.m. – 9:00 p.m.** More information about the project can be found here.

#### **Fairfax Water Performs Spring Flushing of Lines**

Each spring, Fairfax Water flushes its water mains by opening fire hydrants and allowing them to flow freely for a short period of time. Fairfax Water will switch their water treatment method from using combined chlorine (chloramines) to free chlorine, which reacts with sediments suspended during flushing. As a result, your water may have a more noticeable chlorine smell and taste for a few weeks as the free chlorine washes its way through the system. These conditions are not harmful and should not last long. If you are especially sensitive to the taste and odor of chlorine, try keeping an open container of drinking water in your refrigerator, but remember – drinking water has a shelf life! Change out the water in your refrigerated container weekly.

#### **Potholes**

They are a way of life on the roads as temperatures change in the winter and early spring months. With the blizzard behind us, but warmer temperatures right now, <u>please report potholes you encounter!</u>
The Virginia Department of Transportation (VDOT) maintains most primary and secondary roads in the county and fixes potholes. You can <u>look up who maintains every road</u> in the county. VDOT's new online reporting tool, <u>my.vdot.virginia.gov</u>, makes it easier to pinpoint exactly where you see a pothole. You can also report potholes directly from your mobile device and include images (\*\*but NOT while driving!). You can also contact VDOT by calling them at 703-383-VDOT (8368).

#### Zika Virus

Zika virus disease (Zika) is a viral disease spread to people through bites of infected mosquitoes. Mosquitoes become infected by feeding on infected persons. Zika virus is transmitted primarily by Aedes aegypti (Yellow fever mosquito). Aedes albopictus (Asian tiger mosquito) can also spread the virus. Both of these mosquitoes can also transmit dengue and chikungunya viruses. Outbreaks of Zika have occurred in Africa, Southeast Asia, the Pacific Islands, Central America, South America, the Caribbean and Mexico. Because the mosquitoes that spread the virus are found around the world, it is likely that outbreaks will spread to new countries.

Zika virus is mainly spread by mosquitoes. Anyone traveling to an area where Zika virus is found can become infected. Infections have also been reported in travelers returning to the U.S. from affected areas. Those who do not travel to affected areas are not currently at risk of becoming infected with Zika virus from local mosquitoes because local spread in the continental U.S. by mosquitoes has not been reported.

The effect of Zika during pregnancy is being studied. Out of an abundance of caution, the Centers for Disease Control and Prevention (CDC) advises that pregnant women consider postponing travel to countries with ongoing Zika virus transmission.
