ceremony. This project improved approximately 3.6 miles of road between Jeff Todd Way and Telegraph Road, and will improve the quality of life of all those who traverse it. Widening Richmond Highway and better connecting our communities generally are intensely collaborative processes. This project required \$150 million of federal funding, VDOT planning, oversight and contracting and FCDOT planning and support.

Located on this newly widened Richmond Highway section, is the recently completed Belvoir Square apartments. I had the pleasure of attending the grand opening of this five story, 282 unit building. The development includes numerous amenities and leasing has gone very well. On the Lee District side of our shared portion of North Kings Highway, we are fortunate enough to welcome the fourth Bob & Edith's Diner in the Huntington Station shopping center. I greatly enjoyed the food at its grand opening and hope many of you will find time to enjoy as well. Local businesses are an integral, vibrant part of our community, and I am very pleased with the improvements and successes that our newest members are having.

But perhaps the most heartwarming occurrence of all this past month was our community meeting

a couple of weeks ago regarding the drug-related double homicide off of Pohick Road. It was a reminder of just how connected, caring and driven the residents of Mount Vernon District truly are, especially when faced with troubling matters. The community meeting was a great success, with an astonishing 100+ residents in attendance at Pohick Church, who graciously hosted it. Detectives and police officers showed empathy and openness to the community's concerns, making very clear the strong bond we share with our local police force.

Communication is the key for all of us in making a difference and stopping crime. We need you to call the police non-emergency line (703.691.2131) when something seems odd, organize or support a watch group in your neighborhood, ask for increased police patrols when there is ongoing suspicious activity and, most importantly, reach out and connect with your neighbors. While Fairfax County continues to have the lowest crime rate for a jurisdiction of its size, crime still occurs, sadly enough. It is the strength, heart and activism of this district we live in that can make a resounding difference in reducing it.

# Independent Police Auditor and Civilian Review Panel Fully Operational



County Civilian Review Panel (CRP) are now fully operational and ready to receive feedback from members of the public. The Civilian Review Panel's Bylaws may be viewed <a href="here">here</a>. While the Fairfax County Police Department (FCPD) is highly trained and exceptionally professional, incidents can occur that cause a strain between the police department and the residents they so admirably serve and protect. With the establishment of the IPA and CRP, we hope that our residents will use these tools as necessary, in order to voice any complaints they may have with local law enforcement through an outside agency, and with the intention of enhancing trust, accountability and transparency in the community.

Through these new groups residents can file a complaint or request a review of an already completed FCPD investigation of alleged police misconduct. The IPA handles reviews of officer-involved shootings, use of force, deaths while in custody, along with providing reports and making public recommendation concerning polices, training, and practices. The CRP handles reviews of misconduct by an officer and alleged abuses of authority. Examples of complaints and cases the Civilian Review Panel may review are:

- Use of abusive, racial, sexual or ethnic language by an officer
- Discrimination or harassment based on a person's race, color, religion, sex, nationality, marital status, familial status, age or disability
- Reckless endangerment of a detainee or person in custody

You may request a review or file a complaint <a href="here">here</a>. Your review or complaint will then be directed to the appropriate office. The Office of the Independent Police Auditor also provides administrative support for the Civilian Review Panel. # Displaying House and Business Numbers

While it may seem like an insignificant issue, displaying your address numbers is an important topic. This month, make sure your address numbers are in the front of your property and clearly visible from the street. It's important for a number of reasons:

- In an emergency, someone might need to find a house or building immediately
- It's convenient for all of us when looking for a residence or business during daily life
- It's the law! The Virginia Maintenance Code requires that 'all buildings have approved address
  numbers placed in a position to be plainly legible and visible from the street or road fronting the
  property.'

Be sure that your address numbers are also a minimum of four inches tall and in a contrasting color from their background.



### **Displaying House Numbers**

Do you know about Fairfax County's rules for displaying addresses?

- The Virginia Maintenance Code regulates the display of addresses
- The address numbers must be clearly visible from the street, in front of a property
- The address may contain numbers or alphabetic letters
- · The address must be a minimum of four inches tall
- To make sure the address is visible, it must be in a contrasting color from its background.

# Multiple Dwelling Unit Compliance

#### **Multiple Dwellings**

Section 2-501 of the Zoning Ordinance limits the number of dwelling units allowed on a residential lot to one (1). If you notice any activity in your neighborhood related to multiple occupancy, too many people, an excessive number of vehicles, separate entrances on a house, or more than one kitchen at a home on a residential property, you may contact the Department of Code Compliance (DCC) to file a complaint. # Do you know about Fairfax County's zoning rules related to limitations on the occupancy of a dwelling unit?

- Sect. 2-502 of the Fairfax County Zoning Ordinance establishes that a dwelling unit may be
  occupied by not more than one (1) of the following:
  - One family, which may consist of one (1) person OR two (2) or more persons related by blood or marriage with any number of natural children, foster children, step children or adopted children, plus no more than two (2) roomers or boarders unrelated to the family.
  - Two (2) single parents with not more than a total of six (6) of their dependent children.
  - Up to four (4) persons not related by blood or marriage.
  - · A group residential facility.
  - A group housekeeping unit, which may consist of not more than ten (10) persons, which
    requires approval of a special permit by the Board of Zoning Appeals.
  - A bed and breakfast, which requires approval of a special exception by the Board of Supervisors.
- A Home Occupation Permit is required when rooms are rented by boarders in a home. To apply for that permit, please contact the Zoning Permit Review Branch: 703-222-1082.
