A MESSAGE FROM SUPERVISOR STORCK

I would like to thank County Executive Ed Long for nearly 40 years of public service to the residents of Fairfax County. At the September 12, 2017, Board of Supervisors meeting, the Board recognized Ed Long's career with a video retrospective. He will officially retire on September 15, 2017, and the Board will be tasked with finding a new County Executive. Ed Long will be missed, and I wish him well in his next adventures. Lastly, the Board approved the Fiscal Year 2017 Budget Carryover Package, which includes \$35.81 million for funding county reserves and infrastructure based on county policy and \$15.4 million to fund the demolition of the Massey Building.

Admin 2: The Board authorized the Fairfax County Police Department to apply for and accept funding, if received, from the U.S. Department of Justice, Office of Justice Programs, Edward Byrne Memorial Justice Grant in the amount of \$126,799. Grant funding will be used to purchase 46 Forward Infared Scout TK Compact Thermal Night Vision Monocular Devices for patrol operations and one FARO Focused 3D Laser Scanner X130 Mapping Systems to digitally record evidence at crime scenes.

Admin 4: The Board authorized for the Certification of Consistency with the Consolidated Plan as required by the U.S. Department of Housing and Urban Development (HUD) in order to apply for Continuum of Care (CoC) Program funding. The Office to Prevent and End Homelessness (OPEH) coordinates one Continuum of Care Program applications on behalf of various County agencies as well as Fairfax County non-profit organizations. HUD requires that the projects included in the Continuum of Care Program application be certified as consistent with the County's Consolidated Plan. Combating Homelessness for both families and individuals is a high priority in the County's Five-Year Consolidated Plan for FY 2016-2020. The plan was approved by the Board on April 28, 2015. Therefore, the projects in the Continuum of Care Program application are consistent with this priority.

BOARD MATTERS

1. Supervisor Storck's Board Matter to Thank the Land Development Services (LDS) Team for their Exemplary Project Management Expertise and Response to the River Towers Building Event

Background

Recently, an unfortunate event in our county met with a successful resolution through effective collaboration among stakeholders, facilitated by an innovative new Project Management Program in Land Development Services.

On Sunday, October 2, 2016, a serious structural failure occurred at 6631 Wakefield Drive, a 9-story T-shaped condominium building built in the 1960s as part of a development known as River Towers. Columns that were supporting the stem of the building had partially collapsed, resulting in a sudden shift in portions of the building. Residents of the building described the event as similar to the shaking felt during an earthquake. The Building Official immediately ordered the evacuation of 32 of the units while the damage was assessed and repaired, leaving the affected tenants displaced for an unknown amount of time. The River Towers Association, led by a board of volunteers, was understandably overwhelmed with the gravity and significance of the situation as they tackled the task of suddenly managing a multi-million-dollar repair project, while addressing the needs of residents who had temporarily lost their homes.

Recognizing the critical nature of the project, Land Development Services volunteered to assign a project manager from its newly established Project Management Team. The project manager liaised between the Association, the structural engineer and contractor, and multiple Fairfax County agencies. These agencies included the Building Division, the Department of Code Compliance, the Fire Marshal's office, Zoning, Site Review, Department of Housing & Community Development, and the Department of Tax Administration. The project manager communicated regularly with representatives from each of these agencies to understand the status of their individual issues and to ensure processes were aligned to best serve the owners and tenants of River Towers.

The project manager stepped in to connect the dots for all involved, maintaining regular contact, following up on tasks and deadlines, and scheduling coordination meetings to resolve issues as they arose. A weekly report to the Mount Vernon District Office provided updates on the status of plan preparation, permits, repair work, and communications. These regular communications and overall coordination helped to keep the project progressing efficiently. I am pleased to report that the structural repairs to the building were completed and residents could return to their units on June 8, 2017.

River Towers is just one of the examples of the key role a member of the Project Management Team has played in coordinating a complex project with multiple stakeholders. Project managers have assisted developers in efficiently navigating the land development approval process, acting as a liaison for high profile projects, and partnering with stakeholders to help meet a project's goals and milestones.

Project managers use a variety of project coordination tools, which lead to positive outcomes:

- Driving Effective Communication: The project manager establishes a regular plan for communication
 on a project, which could include regular status updates, conference calls, coordination meetings or
 other methods. Delays are minimized when the project manager proactively tracks communication.
- Maintaining Schedules: The project manager can work with the applicant and the various review
 agencies involved to identify a comprehensive schedule agreed upon by all stakeholders. The project
 manager will follow up with individuals responsible for tasks listed in the schedule and track the actual
 time table. The schedule will illustrate how changes in schedule dates will affect later milestones, so
 that all stakeholders fully understand how to minimize the chance of delays.
- Establishing Project Continuity: The project manager is one of the few county staff who stays involved in the project throughout every phase of review and approval. This "common thread" provides a voice of continuity, ensuring that requirements and requests made early in the process do not lose their intent as the project evolves. Similarly, the project manager's experience with implementation and enforcement of approved plans can maximize the chance that the project will get implemented as intended, by recommending strategies to reviewers early in the process.

The Project Management Program, which began as a pilot in June of 2016 as part of the Fairfax First initiative, has been a successful strategy to achieve Goal Three of the Board of Supervisor's Economic Success Strategic Plan: To Improve the Speed, Consistency, and Predictability of the Development Review Process.

2. Joint Board Matter with Supervisor Gross, Supervisor Storck and Supervisor Herrity on Alternative Accountability Program Capstone of the Year Award

Madam Chairman, Supervisors Storck, Herrity, and I were privileged to attend the presentation of the 2016 Capstone of the Year Award to Fairfax County for its Alternative Accountability Program (AAP), a community restorative justice program that serves as an early diversion option for youth involved in the juvenile justice system. The Capstone Award is presented annually by the Center for Juvenile Justice Reform at Georgetown University's McCourt School of Public Policy. Appropriately, the ceremony on September 1 was held in the courtroom of the historic Fairfax County Courthouse, which first opened in April 1800.

A multijurisdictional team from Fairfax County courts, public safety, schools, and the Commonwealth of Virginia, developed a strong, multi-system collaboration designed to increase successful program completion and decrease recidivism among youth, as well as using a data-driven approach to reduce racial and ethnic disparities at the point of system referral. The Fairfax County AAP program competed against 244 others nationwide to be selected for the Capstone Award.

Madam Chairman, in view of this significant achievement, which recognizes intense collaborative efforts between governmental agencies and the community to help at-risk youth succeed, and also is a wonderful example of what might be accomplished under our One Fairfax approach, we ask, without objection, that Bob Bermingham and members of the AAP team be invited to the October 24 Board meeting so that we can learn more about this outstanding collaborative achievement.

PUBLIC HEARINGS

Public Hearing on PCA 91-V-003 (Sumner Crossing Homewoners Association, Inc.)

The Board approved PCA 91-V-003 to allow the applicant, Sumner Crossing Homeowners Association, Inc., to amend RZ 91-V-003, previously approved for 49 single family attached dwelling units to permit the construction of 35 additional parking spaces.

The development features 26 residences that have a one-car garage and driveway, and 19 units with no garage or driveway. There are currently a total of 55 common area parking spaces with 38 spaces reserved for the 19 owners without a garage. In the statement of justification the applicant cities a decision of the Virginia Supreme Court which gives garage unit homeowners the right to the same amount of common area as the non-garage units, including parking spaces owned by the Home Owners

Association. Adding the additional 35 parking spaces will increase the number of common area parking spaces to 90 spaces, enabling all residences to utilize two parking spaces each in the common area.
