Championship on July 26, beating



At the July 25 meeting of the Board of Supervisors, I led the effort for unanimous support of the Board of Supervisors to **approve the Novus/Kings Crossing project**. increased density around the Community Business Centers (CBC) to support Bus Rapid Transit and demonstrates that the Richmond Highway corridor is smartly pivoting to the 21st century.

As a great complement to that development, I was also pleased to announce the same day the county's Kings Crossing/Penn Daw area purchase of **2.32 acres of Quander Family property located at 6318 Quander Road near Richmond Highway.** For more than a year, I have been working with County staff to utilize designated funds to support revitalization and improvements in this Embark CBC area. The county's purchase of this Quander Family property provides a unique opportunity to support the Kings Crossing/Penn Daw CBC development by connecting green spaces,


improving stream restoration, enhancing road access and increasing our flexibility to enable other potential area revitalization improvements. I am extremely pleased to have helped to make this happen.

### Mini Embark Meetings with Supervisor Storck







With roughly 8 months left until the adoption of the Embark Richmond Highway Comprehensive Plan Amendments, Supervisor Storck hosted three "Mini Embark" meetings to discuss the upcoming changes with constituents who live, work, and play in the Huntington, Penn Daw, Beacon Hill, Lockheed Blvd, Hybla Valley, Gum Springs, South County Center, Woodlawn, and Fort Belvoir areas. The meetings were extremely engaging, and residents had the opportunity to ask questions directly to Fairfax County staff who are leading the efforts in revitalizing Richmond Highway.

Embark Richmond Highway is an initiative focused on creating a multimodal future for the Richmond Highway Corridor. Some of the improvements that will be occurring include:


- Implementing Bus Rapid Transit (BRT) along Richmond Highway;
- Planning for nine BRT stations from Huntington Metrorail Station to Accotink Village, Fort Belvoir in Phases I and II of the preferred alternative;
- Evaluating the planned land use density and the mix of land uses within a ½ mile radius of the proposed stations;
- Considering urban design guidance and other elements supportive of BRT;
- Constructing six vehicular travel lanes on Richmond Highway;
- Providing additional vehicular, bicycle, and pedestrian connections along the corridor; and
- Supporting the future Metrorail Yellow Line extension from Huntington to Hybla Valley.

### NOVA Arts/Cultural District Created

In an effort to grow arts and culture tourism, Fairfax County is joining with the Town of Occoquan and Occoquan Regional Park to create an arts and culture district, making it the **first such interjurisdictional district in the state**. The district will allow the area to brand itself as a regional destination for tourism, commerce, and cultural leisure activities.

The NOVA Arts and Cultural District was approved by the Board of Supervisors and will be officially established pending the Town of Occoquan. A new state law that became effective July 1, permits the creation of interjurisdictional arts and cultural districts.

The new district encompasses the 55-acre Workhouse Arts Center in Lorton, the regional park and town. While the new designation will create greater awareness, the region already delivers a rich offering of arts, culture and recreation.



### Update on North Hill



After 35 years, North Hill, a project that will bring much needed affordable, work force, and market-rate housing to Richmond Highway is moving forward in the land use process. CHPPENN I, LLC, the county selected lead developer will revitalize a 35-acre site at the corner of Dart Drive and Richmond Highway by constructing 219 affordable and workforce apartments, 60 affordable independent living units for seniors, 175 market rate townhomes, and a 12 acre public park. Our office has received many inquiries regarding North Hill and the anticipated project schedule, and it is my pleasure to share with you the following information.

### **Update on OMVHS**



The Original Mount Vernon High School located at 8333 Richmond Highway is one of the most iconic buildings in the Mount Vernon District and this 78-year old building sits on 22 acres of land. The county issued a request for proposals to create a master development plan for the adaptive reuse of the school, and the reuse project also includes county-owned land surrounding the school building (totaling approximately 40.26 acres of potential redevelopment land).

Two firms responded to the County's request for proposals: the Alexander Company and S.L. Nusbaum Realty Co. A contract is anticipated to be awarded in early 2018. You can view their plan proposals, <u>here</u>.

### Multiple Dwelling Unit Compliance

#### **Multiple Dwellings**

Section 2-501 of the Zoning Ordinance limits the number of dwelling units allowed on a residential lot to one (1). If you notice any activity in your neighborhood related to multiple occupancy, too many people, an excessive number of vehicles, separate entrances on a house, or more than one kitchen at a home on a residential property, you may contact the Department of Code Compliance (DCC) to file a complaint. ### **Multiple Occupancy**

## Do you know about Fairfax County's zoning rules related to limitations on the occupancy of a dwelling unit?

- Sect. 2-502 of the Fairfax County Zoning Ordinance establishes that a dwelling unit may be
  occupied by not more than one (1) of the following:
  - One family, which may consist of one (1) person OR two (2) or more persons related by blood or marriage with any number of natural children, foster children, step children or adopted children, plus no more than two (2) roomers or boarders unrelated to the family.
  - Two (2) single parents with not more than a total of six (6) of their dependent children.
  - Up to four (4) persons not related by blood or marriage.
  - · A group residential facility.
  - A group housekeeping unit, which may consist of not more than ten (10) persons, which
    requires approval of a special permit by the Board of Zoning Appeals.
  - A bed and breakfast, which requires approval of a special exception by the Board of Supervisors.
- A Home Occupation Permit is required when rooms are rented by boarders in a home. To apply for that permit, please contact the Zoning Permit Review Branch: 703-222-1082.


