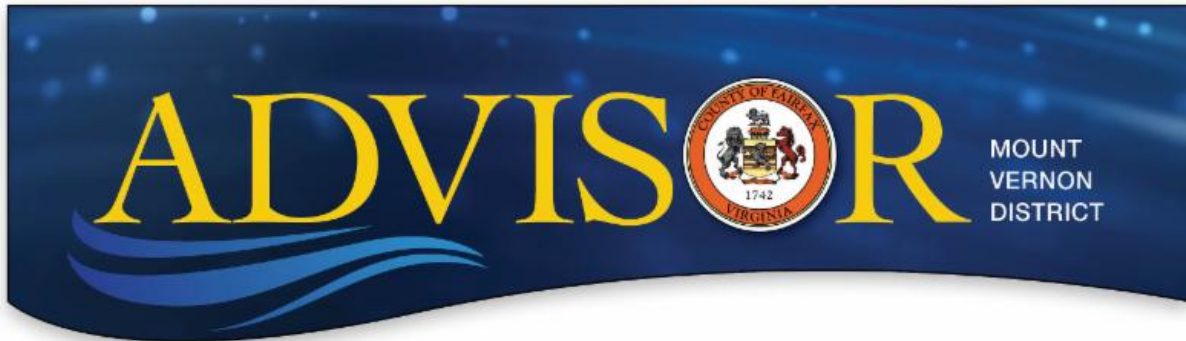

Unfortunately, there is **bad news to report on COVID-19** in our region. After a careful look at the data, our Health Department determined that per CDC guidance we have reached a **"substantial" level of COVID-19 transmission**. Therefore, the Fairfax County Health Department is **recommending that everyone, including individuals fully vaccinated, wear a mask in public indoor settings**. This recommendation is advised as the number of COVID-19 cases has increased with the **spread of the Delta variant**. While this is a frustrating turn in events for everyone, we have the ability to make this better and it is **incredibly important that you get vaccinated**. The data suggests that a **majority of cases** are from those who are **not vaccinated**. In addition, the number of hospitalizations and deaths amongst those who were vaccinated is very low. **As schools reopen**, we need to give **our kids (many are not yet eligible to be vaccinated)** and school professionals a fighting chance at protection. **I urge that you [schedule your vaccine appointment now](#)**.

I hope you get a chance to **unwind and relax this August**. Watch out for information about the **Tour de Mount Vernon on October 23** and other fun fall activities.

### Land Development Services Continues Transition to All Digital



Almost a decade ago, Fairfax County began developing a **new permitting system** that replaces our **outdated plan processing** and **permitting software systems**. **PLUS (the Planning and Land Use System)** provides **one comprehensive system** where all permits and submittals related to entitlement cases, site plans, building permits, construction bonds, fire protection permits, health permits and more **can be tracked and processed**. The first and second phases of PLUS have already launched with more to come over the next two years. Learn more...

### Kirk Park Pedestrian Bridge

The **pedestrian bridge** located in Kirk Park, accessed via the walkway adjacent to **7919 Candlewood Road**, is **deteriorating** due to climate conditions and age. As a result, the **south side of the bridge has been closed** to pedestrian access. The **north side of the bridge will remain open** for single file pedestrian use.



A **stream restoration project** is in the planning stages in the vicinity of the pedestrian bridge that **will include replacing the deteriorating bridge** with a new structure. Work for the stream restoration project and bridge replacement is **scheduled to begin in 2023**.

County staff will **continue to monitor the condition** of the bridge and if it further deteriorates, it **may become necessary to close it** until the new bridge is constructed. ### Fort Hunt Road Improvements

Fort Hunt Road will be **repaved this year** between **Admiral Drive and Belle View Blvd.** ([VDOT 2021 Paving Status Map](#)). **My office** has been **strongly advocating for pedestrian and bike improvements** to FCDOT and VDOT, and working closely and with **Senator Scott Surovell and Delegate Paul Krizek to get these improvements done** during the repaving process. As a result, **wider shoulder areas** will be incorporated to **accommodate bicyclists** where possible. Other improvements are also being incorporated in targeted locations, such as a **new pedestrian crosswalk** at the Sherwood Hall Lane intersection. The project is scheduled to take place the **last two weeks in September**.

### FCPD Releases 2020 Annual Report

The **2020 Annual Report** offers a look back at what was a **difficult year for Fairfax County** and our Nation. The report clearly demonstrates **our officer's commitment to public safety and service**, which evolved last year as we endured the COVID-19 pandemic. Fairfax County emerged from this difficult time with the **continued distinction of**



having the **lowest rate of violent crime** among jurisdictions of its size. This is directly attributable to the **men and women in uniform** as well as a **dedicated group of professional staff** that come to work everyday focused on **keeping people safe**, and a **community that works closely with them**. Crime across all categories had an **overall decrease of 5.33% in CY 2020** compared to CY 2019, and **overall crime year-to-date CY 2021 increases** this **downward trend** we have seen the **last several years**. ### Fairfax County Announces \$18.7 Million Available for Affordable Housing with More Anticipated in FY 2022

The **Fairfax County Redevelopment and Housing Authority** (FCRHA) has announced the availability of local, state, and federal funds to support the **development and preservation** of

**affordable housing in Fairfax County.** More than **\$18.7 million** is currently appropriated and is **now available for multifamily affordable housing development projects**; an additional **\$15 million** in federal funding has been preliminarily identified for this purpose; and additional state funding will be announced in the very near future. ## Inova to Expand Behavioral Health Beds



Inova Health System is looking to **expand its behavioral health capacity**, joining a growing roster of area health systems aiming to **plug the holes for psychiatric care** in the region — and as Covid-19 continues to aggravate the need for these services. The Falls Church-based health system has filed a letter of intent with Virginia to bring **20 more inpatient behavioral health beds** to its **Mount Vernon hospital**. That would **increase the facility's behavioral health capacity by 67%** for a **total of 50 beds** and grow the system's full count by 15% to **153 behavioral health beds**. ## New Food Scrap Composting at Select Fairfax County Farmers Markets - including Mount Vernon

Fairfax County residents have another option for **managing organic wastes** such as fruit and vegetable peels, food left on dinner plates, coffee grounds, and **even paper towels and napkins**. Rather than grinding some of these in a garbage disposal and **sending the particles to wastewater systems** or **tossing them in the trash** where they end up as a significant contributor in landfills, **people can re-purpose food waste**. ### Changes for County Sanitary District Customers

**Starting July 1**, special pickups are **limited to two cubic yards**, or 6 feet long x 3 feet deep x 3 feet high for residents serviced by the **County's waste and recycling services**. Customers are eligible to request **5 special pick-ups per fiscal year** (July 1 - June 30), scheduled in advance (Freon, brush/limbs, bulk, electronic waste, and metal). 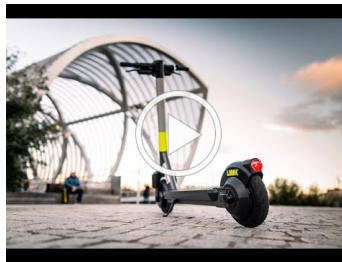

### Mask Wearing Update

Due to **increased transmission of the COVID-19 Delta variant** in many parts of the country, the CDC **issued new guidance** that **recommends fully vaccinated people wear masks indoors** in areas of "substantial" or "high" COVID-19 transmission. Based on this guidance, the **Fairfax County Health Department** now recommends that everyone, including **individuals fully vaccinated** against COVID-19, **wear a mask in public indoor settings**. As the number of COVID-19 cases **has continued to increase** with the spread of the Delta variant, this recommendation is based on the **Fairfax Health District moving from moderate level of COVID-19 transmission to substantial transmission**. Indoor masking is an important approach to prevent further spread of COVID-19 and should be combined with other strategies or "layers of prevention." **In addition to masking, residents should:**

- **Get vaccinated** if they have not done so already. Despite some breakthrough cases, vaccination remains the most important approach to prevent COVID-19 and particularly to prevent more severe infection. No appointments are needed and [walk-ins are available](#). Vaccinations are free.
- **Stay home when you're ill** except to get tested or see a healthcare provider.
- Maintain **6 feet physical distancing** from others.
- Practice good handwashing.



- **Get tested if symptomatic** or if you spent time with someone who is sick or tested positive for COVID-19.
- Adhere to **health department recommendations** for isolation and quarantine if you are infected or are a close contact of an infected person.
- Stay in touch with the [most current information in Fairfax County](#).

The vaccine is still the **best way to protect ourselves and each other**. If you or someone you know needs the vaccine, **appointments are FREE and readily available across our region**. In the County, **more than 75% of people 18 or older have received the vaccine!** But our efforts must continue until everyone who can be vaccinated is. Last week, the Board approved Chairman McKay's motion directing the County Executive to **explore the adoption of a vaccine requirement** for County employees, with the appropriate religious and medical exceptions.

## Homebound Vaccine Program

For the past six months, the **County's Health Department staff and Fire and Rescue Department firefighter/paramedics** have been working to bring the **COVID-19 vaccine** to those who need to be vaccinated but **cannot leave their homes**. Through this successful partnership, nearly **600 homebound residents** have been vaccinated. [Learn more...](#)

# Important Safety Information

## 9-1-1 Emergency Health Profile

**Create a free emergency health profile** so your critical health and medical information can be **shared with first responders** during an emergency or crisis event. Your emergency health profile will **provide real-time health, medical, emergency contact, and background information** to first responders when it matters. Creating a profile is easy and takes **only a few minutes**. Behavioral health information, pre-existing medical conditions, allergies, emergency contacts and more can be entered into the **voluntary database**. [Learn more...](#)

## Compliance Corner: Freestanding Accessory Structure

An accessory structure is defined in the Zoning Ordinance as: A building or structure that: (1) Is **subordinate in purpose to a principal building** or a principal use legally existing on the same lot; and (2) **Contributes to the comfort, convenience, or necessity** of the occupants, business, or industry of the principal structure or principal use served on that lot. Examples of freestanding accessory structures include **detached garages, sheds and gazebos**.

In addition to meeting the definition above, the structure **may also need to be located away from property lines** (lot lines) by a certain distance. For freestanding accessory structures, these distances away from lot lines are referred to as **location regulations**, which most **often depend on the structures' height**. Freestanding accessory structures potentially violating the location regulations of the Zoning Ordinance are among the **most common complaints and concerns** received by the Department of Code Compliance (DCC). ## Bird Mortality Event Update

The **Virginia Department of Wildlife Resources (DWR)** recently released another update regarding the **bird mortality event in our region**, and multiple other states. **No definitive cause(s) of illness or death** have been determined at this time. The number of reports of **affected birds in our area has declined** but the DWR is continuing to recommend that people **discontinue bird feeding** until they provide notice that the mortality event is believed to be concluded. In late May, wildlife managers in multiple states, including Virginia, **began receiving reports of sick and dying birds** that were exhibiting eye issues (swelling, crust discharge, etc.), along with neurological symptoms. Frequently reported species and age classes observed exhibiting these symptoms were **young common grackles, blue jays, European starlings and American robins**. [Read the full report...](#)

#### **A. Heath Onthank Award Selection Committee**

To grant recognition for accomplishment of outstanding worth in advancing and improving public service in County by merit system employees.

#### **Advisory Social Services Board**

To interest itself in all matters pertaining to the social welfare of the people served by the government; to monitor the formulation and implementation of social welfare programs; to meet with the Director of Social Services at least four times a year for the purpose of making recommendations on policy matters; to make an annual report to the governing body concerning the administration of the public welfare program; and to submit to the governing body other reports that the advisory body deems appropriate.

#### **Affordable Housing Advisory Council**

Recognizing that housing is foundational for all, the purpose of the Council is to provide recommendations to the Board of Supervisors, consistent with the One Fairfax initiative, regarding the implementation and achievement of the Communitywide Housing Strategic Plan, County resource requirements identified in the annual Budget Guidance, any additional adopted affordable housing development or preservation guidance, as well as recommendations on overarching policies and programs that synthesize County efforts related to both housing affordability and homelessness.

#### **Community Action Advisory Board**

Advises the Fairfax County Board of Supervisors on the needs, concerns and aspirations of limited-income persons; and recommends policies that promote meaningful change.

#### **Wetlands Board**

The board shall preserve and prevent the despoliation and destruction of wetlands within its jurisdiction while accommodating necessary economic development in a manner consistent with wetlands preservation. The objectives and procedures of the Fairfax County Wetlands Board (the Board or the Wetlands Board) are those set forth in Title 28.2, Chapter 13 of the Code of Virginia, (Virginia State Wetlands Act) and in Chapter 116 of the Code of Fairfax County (Wetlands Zoning Ordinance).

#### **Young Adults Advisory Council**

To advise the Fairfax County Government, as coordinated through the Fairfax County Department of Economic Initiatives, by contributing young adults' experiences, knowledge, and solutions to County issues.
