SWA 21-005 SECOND UPDATE


SUSPENSION OF COMMERCIAL TIRE DISPOSAL

This Solid Waste Advisory (SWA) supersedes and serves as a second update to the original SWA 21-005, which was issued on August 27, 2021 and originally updated on October 28, 2021. Effective September 1, 2021, due to operational constraints and environmental compliance, disposal of tires from commercial collectors has been suspended until further notice.
