

• The turn of the century. When I was a little girl, I couldn't imagine living that long. After all, I would be in my 50's! Needless to say, that doesn't seem so old now and sure enough, a brand new century is about to begin. Complementing springtime's promise of growth and renewal, my next **TOWN MEETING** will be an occasion to pause from our busy day-to-day activities and contemplate what lies ahead. When trying to imagine our future, I recall old 1950's film footage of enormous cars with spaceship-like fins folks thought we'd drive during the next decades. Instead, we've embraced fuel-efficient compacts. What do the demographers, economists, religious leaders, and high tech gurus predict our future will be? What do we *want* it to be? How can we help shape a positive future for ourselves, neighbors and families? With the Board's consideration of renewing Media General's franchise agreement, it's timely to contemplate the role of technology in our future. Your ideas, suggestions and imagination will ensure a lively and exciting gathering. I hope you can join me on **Wednesday, June 10th** for the first of several Town Meetings entitled **BRADDOCK 2000 - A Miniseries**. If you are not able to join us at **Little Run Elementary School**, you can watch the program live on Channel 16. Call my office for information about rebroadcasts.

• **The 1998 Fiscal Year BUDGET** was adopted on April 28th with strong bipartisan support. Thanks to actions taken last year, when the County was projecting a \$150 million deficit, this budget has been described by journalists as "boring". The Board resolved last year's spending gap by, in addition to a 7 cent tax rate increase, eliminating or reducing \$55 million in services and terminating 477 positions. For the first time, the Board closed a number of facilities, programs and offices we felt were affordable during the 80's, but no longer so in the more austere 90's. *While Fairfax County's population has grown by more than 94,000 since 1990 (the equivalent of five Fairfax Cities), we have 559 fewer county employees serving the public.* In addition to strict Budget Guidelines, this year's process was also aided by a newly created Competitive Community Funding process which brings discipline to the task of funding our non-profit human services partners. The Board continues to pursue reorganizational opportunities to reduce the cost of government. My personal philosophy is that, while we may discontinue some services, we must continue to provide quality and satisfaction in the services we value most and continue to provide.

• Thanks to sponsors The Washington Post and Giant Food (and contributors Virginia Power, Washington Gas and Media General Cable), **BRADDOCK NIGHTS** returns to the Braddock District this summer! Once again, Friday evening concerts will take place at **Lake Accotink** in Springfield and **Royal Lake** in Fairfax. ROADWORKS UPDATE

Roberts Rd. Extension - Complete a two lane segment of Roberts Rd. from Collingham Dr. to north of Colony View Dr. (State Project - 0.4 mile) Last December, following VDOT's preliminary design hearing, I walked the length of this project with State and County transportation staff to meet with residents who would be most directly affected by the extension. VDOT has held the design width of the road to minimum standards. I'm working with State officials to try to get fencing and trees for residents who back up to the project. Except for some fine tuning, design is essentially complete. Construction is expected to begin in spring '98 and should take about 6 to 9 months to complete.

Roberts Rd. Flyover - Construct grade separated intersection with Norfolk Southern Railroad tracks (State Project) VDOT has scheduled a public hearing on the preliminary design for this project on June 12th from 4 - 8 P.M. at the Bonnie Brae Elementary School. In order to address issues specific to residents of Colony Park and Whitfield Green, I have arranged to host a separate briefing for them on June 18th at 7:30 P.M. at Bonnie Brae. Construction of the Roberts Rd. Flyover is planned to begin in 1999.

Guinea Rd. - Roberts Rd. to Pommeroy Dr. (State Project - 1.5 miles) Widen from two to four lanes. Funded for very preliminary design. **New Guinea Rd. along the front of Colony Park will be widened in conjunction with the Roberts Rd. Flyover project and will be discussed at the June 18th briefing.**

Burke Centre Parkway - From Marshall Pond Rd. to Burke Lake Rd. (County/State Project - 0.87 mile) Widen from two to four lanes. In final design. Land acquisition to follow. Construction goes to bid in July 2000.

Rt. 123 (Ox Rd.) - From Burke Lake Rd. to the Occoquan River (State project - 7 miles) Widen Ox Rd. to four lanes (with right-of-way for a future six lanes). Public hearing on design in early '98.

Shirley Gate Rd., Extended - From Braddock Rd. to the Fairfax County Parkway (State Project - 0.9 mile) This project will connect Shirley Gate Rd. to the

Fairfax County Parkway. Conceptual and alignment studies are under way. This project is funded for design in the State's Six Year Plan in 2002.

I-95/I-395/I-495 (Mixing Bowl Project) - This multi-phase \$270 million project to reconstruct this major interchange is in final design. The entire project will take about ten years to complete. VDOT public hearings are scheduled for June 19 & 20. For more information call 324-1100.

Woodrow Wilson Bridge Project - Study completed to replace this 35 year old Federal bridge. Fairfax County is supporting a twelve lane side by side draw bridge to include HOV. Financing for this major construction project and whether it will be partially supported with a toll is yet to be decided.

Route 236 Corridor Improvements - Improve traffic flow on Rt. 236 between Hummer/ Heritage and Pickett Rd. in the City of Fairfax with some additional turn and through lanes. Project should be on State's Six Year Plan by this summer. Federal funding will be sought for design and construction which is estimated at \$6 million.

Braddock District Spot Intersection Improvements (County Projects) - Three "quick fix" traffic improvements recommended by the Braddock District Council of Community Associations and Braddock residents have been approved:

Extend right turn lane on northbound Guinea Rd. at Rt. 236 - Project in design. Spring '97 construction


Close median break on westbound Braddock Rd. to prevent left turns into Ravensworth Shopping Center - Design completed. Fall '97 completion.

Construct right turn lane on northbound Rt. 123 at Middlegate Dr. In design.

AT WORK FOR YOU**



George Mason Regional Library in Annandale is undergoing a \$5.7 million renovation. A temporary facility is operating seven days a week, Mon - Thurs 10 A.M. - 6 P.M.; Sat 10 A.M. - 5 P.M.; and 12 noon - 6 P.M. on Sun. It houses 42% of George Mason's circulation as well as an on-line data base. Grand opening of the renovated building in spring '99.

The Fairfax County Park Authority continues to improve **Lake Accotink Park** with construction of a pedestrian bridge and trail over the Norfolk Southern train tracks. This long awaited improvement will make the park more accessible and safer.

Pleasant Valley Golfer's Club is an 18-hole daily fee public golf course being developed jointly by the Fairfax County Park Authority and a private developer. The golf course will be constructed under terms that allow the developer to construct and operate the course on parkland in return for a percentage of the revenues. After 25 years, the Park Authority assumes full ownership. The club will be located at 16200 Lee Road, Chantilly. Opening is scheduled for spring '98.

Chestnut Hills/Fairfax Hills Sanitary Sewer

Project: Construction is 55% completed and should be finished later this summer. **Holly Park Sanitary Sewer Project:** Engineering and land acquisition are completed. If 50% of residents pay the availability fee, construction could begin this fall and be completed in early '98. These projects are *cost shared with affected property owners* for extension of sewer service where failing septic systems pose a problem.

CABLE FRANCHISE RENEWAL

Fairfax County's 15 year franchise with Media General Cable (MGC) expires in September. Federal law requires localities to negotiate first with their current cable provider before deciding to renew or terminate that relationship. The reasons for *not* renewing a franchise agreement are limited by legislation. Fairfax County's Department of Consumer Affairs is collecting comments on MGC's past performance, rates and services. They will also be conducting focus group sessions with neighborhood organizations to identify needs and interests. This fall, public hearings will be held at the Government Center. 1997 COMPREHENSIVE PLAN REVIEW

In Fairfax County, development of both land and transportation is guided by the Comprehensive Plan. First adopted in 1975 and amended over the years, the Plan, while not law, is a major guiding factor when a landowner requests a change to his zoning. If challenged in court, decisions about land use are weighed in context with the Comprehensive Plan.

The Board of Supervisors has designated 1997 as a Review Year for the Plan. During this time, anyone can submit a nomination to modify the Plan. As in previous years, I have assembled a **Citizen's Plan Review Task Force**. This task force consists of 26 community volunteers who responded to articles in my *Braddock Byline* and letters to community association representatives. The group has been meeting since January, learning about Fairfax County land use regulations and reviewing areas of the Plan that affect Braddock. As a result of their review, they have made a number of their own recommendations. They are also evaluating nominations submitted by the public.

Public hearings regarding Comprehensive Plan changes will be held by the Planning Commission and Board of Supervisors later this fall. Prior to that, I will be hosting two **town meetings** so that interested neighbors can learn about the nominations and express support or opposition to the changes:

COMING SOON! NEW STREETS & SIDEWALKS



In Fairfax County, the State's Department of Transportation (VDOT) owns and maintains sidewalks and streets. My office works closely with VDOT to ensure that the interests and needs of our Braddock Community are addressed. This year, VDOT contractors will be

replacing sidewalk, curb and gutter in the following communities: *Chapel Square, Chapel Square West, Oak Hill, Chapel Hill, Fairfax Villa, Burke Centre, Kings Park West, Maywood Terrace, Briarwood and Waverlee Woods.*

In April, I arranged for VDOT officials to brief community association representatives on the work to be performed. Work will begin in May, and continue into early winter. A few days prior to working in an area, VDOT personnel will place cardboard hangers on area front doors indicating the inspector to contact in case of problems. Before actual construction "Miss Utility" will mark for buried utility lines and VDOT personnel will spray paint sidewalks to be replaced. Sidewalks with "temporary" asphalt patches will be replaced.

Sidewalks will be removed using a backhoe. Homeowners should alert VDOT to the presence of sprinkler systems buried in the grassy utility strip (property located between your sidewalk and the curb). This would *not* show up when Miss Utility marks the area and because it is on VDOT's property would not be repaired or replaced if damaged. If possible, they will try to avoid it. Answers to other frequently asked questions:

Why is a certain stretch of sidewalk replaced while another is not? What are the criteria for replacing sidewalks? Each section of sidewalk is a judgement call by VDOT. Sometimes a sidewalk appears to be in good condition, but is eroded underneath, causing cracking, swelling and/or collapsing of sidewalk segments further down the road. The erosion problem is corrected by removing whole sections of sidewalk and placing gravel and piping underneath new concrete.

What about my trees in the utility strip between the sidewalk and street? Sometimes the roots of older trees rise to the surface under the sidewalk causing it to swell and/or crack and eventually destroying the sidewalk. VDOT will discuss the removal of problem trees individually with homeowners prior to taking any action. VDOT must be able to negotiate its equipment next to your property in order to work. Please trim back branches that may interfere with their access.

Does VDOT put down sod or grass seed? VDOT requires that grass or sod (depending on the season and weather) be planted before the contractor has completed the project. This is not necessarily *immediately* after concrete is poured. If you want to replace the area with your own grass seed, please let the contractor know about your plans.

Can I privately arrange with the contractor to have a new driveway poured while work is already being done in the area? Yes, as long as the work does not interfere with the overall schedule for the contract.

Now that our sidewalks are being replaced, when can we expect our streets to be resurfaced? The condition of neighborhood streets is evaluated by VDOT and given priority order for resurfacing, similar to sidewalk work. VDOT plans to repave some streets in the following areas this year: *Somerset/Old Creek, Hickory Farms, Middleridge, Kings Park West and some adjacent areas, Fairfax Villa, part of University Drive, Roberts Rd. from Braddock to Fairfax City, Rt. 123, and Guinea Rd. from Commonwealth Blvd. to Zion Dr.*

VRE and METRO News

Virginia Railway Express and Metro have a new joint Transit Link Card known as "VRE-TLC". This "all-in-one" fare card enables riders to take unlimited rides on VRE and Metro for one discounted price. The cards are good for a month and may be purchased at any of the Arlington Transit Stores or by mail. For more information, call 413-4287.

RABIES UPDATE



Rabies presents a real danger to public health in Fairfax County. Cases of rabies have been on the increase State wide. The most commonly affected animals are raccoons, with foxes and ground hogs a distant second. Citizens should stay away from all wild animals and keep pets from coming into contact with animals in the wild. If you observe any animal exhibiting unusual behavior or showing signs of illness, contact Animal Control at 830-3310. If bitten by a wild or stray animal, wash the wound immediately and thoroughly, apply antiseptic, seek medical attention and report the incident to Animal Control. State law and County ordinance require that dogs and cats, four months of age and older, be inoculated. The County holds rabies clinics every other month at the Government Center. Clinics are scheduled for July 13, September 14 and November 9 from Noon to 2 P. M. Cost for the vaccinations is \$4 for one year and \$6 for three years. 

• Recently a newspaper reporter called me to confirm a rumor that our **NEW COUNTY EXECUTIVE BOB O'NEILL** (on the job for five weeks) "was going to reorganize something". I replied, "Well, I certainly hope so! That's one of the reasons we hired him." Bob says his major challenge this year will be learning about Fairfax County. So far, his meetings with groups and organizations throughout the County have won him high marks. Bob describes our County work force as "incredibly talented". He intends to "get people thinking in new ways", to meet the demands for "high quality service with competitive tax rates". His enthusiasm is infectious and I'm looking forward to working with him. Bob's first "Baptism by Fire" will most likely be his handling of our Fiscal Year 1999 Budget early next year. **A briefing on the County Executive's Recommended Budget** will be presented at the **Braddock District Council of Community Association's March meeting (7:30 P.M., March 12th)**. This annual event, held here in my Chapel Square office, is open to the public. I hope you'll have a chance to attend, meet our new County Executive, and comment on his proposed spending plan.

How have changing demographics been handled through the years? Are there things we can (and should) do now to prepare for an increasingly diverse population to help shape a positive future for ourselves, neighbors and families? Your ideas, suggestions and perspectives will ensure a thought provoking forum. ROADWORKS UPDATE

Roberts Rd. Extension - Complete a two lane segment of Roberts Rd. from Collingham Dr. to north of Colony View Dr. (State Project - 0.4 mile) The Virginia Department of Transportation (VDOT) has designed the width of the road to minimum standards in order to reduce the amount of land disturbed to construct this project. Thanks to the fine efforts of the Braddock District Plan Review Task Force, VDOT further reduced the impact of the project south of Zion Drive. The redesign more closely follows the existing topography, thereby reducing the scope of the project both vertically and horizontally. I'm continuing efforts with State officials to include some fencing and trees for residents who back up to the project. Except for some fine tuning, design is complete. Bid advertisement is scheduled for early '98 with construction to begin in spring/summer '98. This project should be completed by the end of the year.

Roberts Rd. Flyover - Construct overpass over the Norfolk Southern Railroad tracks (State Project) In addition to the overpass, there will be significant safety improvements at both approaches to the bridge. South of the tracks, the conflicting turning movements on Roberts Parkway at Premier Court, the Burke VRE Station and the Burke Commons Community Center will be addressed by means of a single access point at the community center controlled by a traffic signal. North of the tracks, there will be dual right turn lanes on north/east bound Guinea Road with a traffic signal at Roberts Road and Guinea Road. In order to avoid future disruption to Colony Park, VDOT will widen Guinea Road along Colony Park as a part of this project. When the flyover is completed, the new traffic signal, located where the traffic circle used to be, will be eliminated and Old Guinea Road will dead end north of the tracks.

Following VDOT's public hearing in June, I held a special briefing for the residents of Colony Park and Whitfield Green. An outgrowth of that meeting was the formation of a "**Bridge Design**" Task Force, comprised of over 20 neighborhood volunteers. We've been meeting with officials from VDOT, their consultant and the County's Office of Transportation to provide guidance on materials and design which will ensure that the bridge is an attractive community landmark. Construction of the Roberts Rd. Flyover is planned to begin in 1999.

Guinea Rd. - Roberts Rd. to Pommeroy Dr. (State Project - 1.5 miles) Widen from two to four lanes. Funded for preliminary design in 2000.

Burke Centre Parkway - From Marshall Pond Rd. to Burke Lake Rd. (County/State Project - 0.87 mile) Widen from two to four lanes. Final design completed. Land acquisition to follow. Construction goes to bid in July 2000.

Rt. 123 (Ox Rd.) - From Burke Lake Rd. to the Occoquan River (State project - 7 miles) Widen Ox Rd. to four lanes (with right-of-way for a future six lanes). Public hearing on design in summer '98.

Shirley Gate Rd., Extended - From Braddock Rd. to the Fairfax County Parkway (State Project - 0.9 mile) This project will connect Shirley Gate Rd. to the Fairfax County Parkway. Conceptual and alignment studies are under way. It's funded for preliminary design in the State's Six Year Plan in 2000.

Route 236 Corridor Improvements - Improve traffic flow on Rt. 236 between Hummer/ Heritage and Pickett Rd. with some additional turn and through lanes. Following meetings with affected communities last year, the project was added to State's Six Year Plan this summer. Federal funding will be sought for design and construction which is estimated at \$6 million. Funded for preliminary design.

Braddock District Spot Intersection Improvements (County Projects) - Three "quick fix" traffic improvements recommended by the Braddock District Council of Community Associations and Braddock residents have been approved:

Extend right turn lane on northbound Guinea Rd. at Rt. 236 - Fall '97 construction

Close median break on westbound Braddock Rd. to prevent left turns into Ravensworth Shopping Center - Will eliminate dangerous turning movements which cause high accident rate and congestion. Design completed. In final review by VDOT.

Construct right turn lane on northbound Rt. 123 at Middlegate Dr. In design. Proposed rezoning of Keys property includes a proffered contribution toward the cost of construction.



WORKIN' ON THE RAILROAD

It's been a rough year for the Virginia Railway Express (VRE). Ridership on the Fredericksburg line was affected by the opening of new HOV lanes on I-95. Then, service was disrupted by a freight train derailment just north of Crystal City in July. CSXT repairs interfered with VRE train schedules (we are tenants on their tracks). Blood pressures rose along with the summer temperatures, until VRE service was finally fully restored on August 18th. Since then, on-time performance has been 95%.

With the arrival of autumn, cooler heads will be sitting down to sort out "What went wrong?" and "How do we make sure it doesn't keep happening?" On October 8th, our Northern Virginia Delegation of the General Assembly and VRE management will meet with CSXT officials to discuss the poor response they provided during July and August with our goal being to maintain the *current* high level of on-time performance. *The VRE is an important piece of the transportation network mosaic for the area.* It's important that we take the long view and ensure it's viability. To that end, a number of recent events will make VRE ridership even more convenient and dependable:

- On July 1st, VRE joined with Federal and State officials and private sector partners to launch the **SmarTraveler Information System** - the first phase of a new state-of-the-art traveler information service for the region. The system will give commuters easy access to on-demand, real-time route-specific information regarding traffic and transit conditions. VRE passengers will be able to receive a personal alert when their specific train is delayed.

- **The Franconia-Springfield Metrorail Station** opened in early July. VRE and the Fairfax Connector are marketing combined rail and bus travel for commuters with jobs at Ft. Belvoir and the Springfield business community. VRE passengers also have the added flexibility of using Metrorail in cases where they may need to get home in the middle of the day or if they miss their VRE train and need an alternative way home. The new parking deck contains 3,800 spaces of secured covered parking.

"HAPPY TRAILS TO YOU" - FINALLY!

For the first time in many years, some funding for trail projects was approved in the FY 1998 budget. With over 100 projects Countywide competing for only \$1 million in funding, certain criteria were established: safety, anticipated ease of implementation and need. Each district was allotted \$100,000 with an additional \$100,000 for a Countywide project. Here in the Braddock District, three projects were selected:

- **Woodland Way, Annandale** - from the Woodland Meadows Community at Woodland Way and Braddock Road to Fleming Drive. Total cost of this 400 foot project is \$59,000. This segment will complete the sidewalk along Woodland Way, providing an important link for walkers to Canterbury Woods Elementary School.
- **Guinea Road, Fairfax** - west side of Guinea Rd. from Braddock Road north to Rutherford Park. \$10,000 is provided for preliminary engineering for this long awaited safety project. Total cost of this 3,400 foot project is estimated at over \$1 million.
- **Bonnie Brae Elementary School, Burke/Fairfax** - from Whitfield Court to Calumet Grove Drive. \$30,000 for design and land acquisition for this school walking path which would serve children in Whitfield Green. Total cost of this 450 foot project is estimated to be \$180,000.

COMING SOON! BUS SHELTERS

Federal Congestion Mitigation and Air Quality (CMAQ) funds will be used to purchase nine bus shelters throughout the County.

One will be located on Braddock Road at Wakefield Chapel Road this winter. An additional bus shelter on Route 236

(westbound) at Northern Virginia Community College

may be installed when additional grant funds become available this winter.



CABLE FRANCHISE RENEWAL

In September, the Board of Supervisors approved a six month extension of Media General Cable's (MGC) franchise in order to allow them adequate time to respond to the County's franchise solicitation document (RFRP). Under this new timeframe, public hearings will likely be held in January 1998 and a decision rendered by the Board of Supervisors in February. The County's RFRP requests MGC to provide a state-of-the-art television network, capable of delivering interactive services, ala carte programming, high-speed access to the Internet and more. The County's request also asks MGC to provide continued support for public, education, and government access users. MGC's response to the RFRP is due to the County in late October, after which we will begin a comprehensive analysis of the proposal to determine if it meets the present and future needs of the community.

The County's Cable Administrator and staff are conducting focus group sessions in each District. One Braddock District briefing was held in June and another will be the subject of an upcoming Braddock District Council of Community Associations' Meeting. TAX ABATEMENT PROGRAM

On June 23, 1997 the Board of Supervisors approved a major revitalization program. As authorized by State law, the Board provided a tax abatement incentive for property owners to improve and maintain existing housing and commercial buildings in the County.

Under the program, offered countywide, qualified owners will receive real estate tax credits for the rehabilitation, renovation or replacement of older buildings. Owners who meet all program requirements will not have to pay taxes on the increased value of their property for ten years. To qualify, a residential structure must be a least 25 years old, and the improvements must increase the assessed value of the structure by at least 25 percent. For more information about qualifying and applications, contact the Fairfax County Department of Tax Administration at 222-8234.

AUDIT HOTLINE AVAILABLE

The Board of Supervisors has established an audit hotline to allow citizens to suggest ways to increase County government efficiency and improve services. Anyone may report instances of alleged waste, fraud or mismanagement in County Government. The hotline, available 24 hours-a-day, can be reached by calling **876-0525**. All calls are kept strictly confidential and will be reported to the Financial and Programs Auditor to the Board of Supervisors for assessment and investigation.

RABIES

Because of several recent incidents of rabies detected in animals in Fairfax County, all citizens are advised to take



precautions to recognize rabid behavior and protect themselves. Although most of the cases did not involve human exposure, rabies *does* present a real danger to public health in Fairfax County.

If you observe any animal exhibiting unusual behavior or showing signs of illness do not hesitate to contact the Department of Animal Control at 830-3310. Make sure that you let the call taker know if an emergency exists. Animal Control has recently taken actions to improve response time of animal wardens to these types of situations.

Fairfax County is now operating a rabies infoline at 324-BITE (324-2483). Citizens may call this number at any time for recorded weekly updates on the latest total of confirmed cases of rabies in the County. Wildlife most commonly infected with rabies are raccoons, but foxes, groundhogs, skunks and bats are also carriers.

The law requires that dogs and cats be inoculated for rabies. The vaccine must be administered every one or three years, depending on the vaccine and age of the animal. Information about rabies clinics is available by calling the Shelter at 839-1100.

ELECTION DAY - NOVEMBER 4TH

On November 4th we will be voting for our Governor, Lieutenant Governor, Attorney General and State Delegates. Voters will also have the opportunity to vote for a \$232,850,000 School Bond Referendum which will provide funds for public school construction. These bonds will pay for new schools, school additions, renewals, and renovations. Braddock District schools in line for improvements under this Bond Referendum:

- **Braddock Elementary School** - \$1.9 million for six classroom additions
- **Kings Glen Elementary School** - \$6.4 million for renewal
- **Annandale High School** - \$4.2 million for progressive renovation



1997 COMPREHENSIVE PLAN REVIEW

In Fairfax County, development of both land and transportation is guided by the Comprehensive Plan. First adopted in 1975 and amended over the years, the Plan is a major guiding factor when a landowner requests a change to his zoning. If challenged in court, decisions about land use are weighed in context with the Comprehensive Plan.

The Board of Supervisors designated 1997 as a Review Year for the Plan. During this time, anyone could submit a nomination to modify the Plan. As in previous years, I assembled a **Citizen's Plan Review Task Force** consisting of 26 community volunteers who responded to articles in my *Braddock Byline* and letters to community association representatives. The group learned about County land use regulations and reviewed areas of the Plan that affect Braddock. As a result of their review, the Task Force made a number of their own recommendations and evaluated nominations submitted by the public.

In July and September I hosted three town meetings for potentially affected neighbors to learn about the nominations and express support or opposition. Formal public hearings were held by the Planning Commission in September. The Board of Supervisors hearings will be later this fall. **Please contact my office for information about the nominations or to volunteer to serve on future Comprehensive Plan Reviews.**

WHAT IS A STORMWATER UTILITY FEE AND WHY DO WE NEED IT?

As Fairfax County has developed we've been faced with the effects of increased stormwater runoff - eroding stream banks and silt in our lakes. In recent years, we have developed more sophisticated control measures and now require developers to pay their fair share for improvements. The needs, however, are far greater than our ability to correct them. For example, there is currently a backlog of over 600 unfunded projects. They run the gamut from Federal mandates for clean water to private homes with house and yard flooding.


In order to deal with this statewide problem, the General Assembly passed enabling legislation in 1991 that allows localities to establish a Countywide system for surveying the amount of impervious surfaces on residential and commercial/industrial properties and for assessing a fee to allow us to address the damage to our environment. Since 1992, a Countywide task force of citizens and business leaders has been studying this issue. Language for a new ordinance has been drafted and public hearings are planned for late this year or early next year.

The children benefit from our good water, healthy food, fresh air, sunshine, exercise and warm friendships. They also receive dental and medical checkups and treatments. FAITH COMMUNITIES IN ACTION

Several years ago, we began an effort in the Braddock District called "Faith in Action". It is an opportunity for religious leaders of all denominations to get together quarterly with County officials to network, share information and learn more about what is going on in the County. This allows all of us to leverage and make improved use of our resources. With the advent of Welfare Reform on the State and Federal levels and Federal legislation affecting benefits to immigrants, a Countywide "Faith Communities in Action" sprang from our Braddock District forum. It serves as an umbrella organization to facilitate communication between interfaith groups throughout Fairfax County.

As we enter the next century we are seeking better, more humane and compassionate ways of helping the less fortunate among us. An important element to our new approach will be *partnerships* among local and state government, charitable non-profits, fraternal organizations (Optimist Clubs, Rotaries...) and the religious community. Religious and community-based organizations can provide the critical people-to-people ingredient and support network that government is just not equipped to provide.
