20-81-100.E	Unauthorized waste program and inspection - The facility ceased accepting construction demolition and debris on August 3, 2018.
20-81-140.A.16	Facility self inspections - The facility confirmed that monthly self inspections were performed. The self inspection record for January 2021 was reviewed; no compliance issues were noted.
20-81-485	Operations Manual - David Howard recertified the Operations Manual on April 30, 2020.
20-81-530	Permittee recordkeeping and reporting - The facility provided the 24 hour notifications and the five day written submissions for the gas exceedances in the gas boundary wells.
20-81-140.A.6	Pollutant discharge - The landfill was inspected; no leachate seeps were observed.
20-81-140.A.7	Stormwater control system maintenance - The sediment basins and stormwater conveyance channels were inspected; no compliance issues were noted.
20-81-140.A.9-13	Hazard and nuisance control - The landfill was inspected: litter was not observed.
20-81-160	Closure requirements - The facility had completed the construction of the final CAP.
20-81-200	Decomposition gas control - In June 2019, the facility was issued a Warning Letter for a compliance level exceedance in gas boundary wells on the western boundary of the property. The facility last exceeded the compliance level for methane in boundary wells GP-18 and GP-19 on January 21, 2021. The facility installed passive gas vents in the vicinity on GP-18 and GP-19 in November 2020. The gas flares and blowers were inspected: no compliance issues were noted.
20-81-210	Leachate control - The facility transported 12,000 gallons of leachate for treatment to the Waste Management treatment facility Sussex County on January 11, and February 4, 2021. The above ground storage tanks (ASTs) where the leachate is stored were inspected; no compliance issues were noted.
20-81-250	Groundwater monitoring program - Five groundwater monitoring wells were inspected The groundwater monitoring wells were: locked, labeled, and in good working condition.
